The Sierra Leone Sexual Offences Act was enacted in August 2012 after two years of deliberation. The purpose of the act was to address the high rates of violence against women and to end the culture of impunity that exists in Sierra Leone. This violence spiked in the 11 year civil war but still remains extremely high.
